# TERMS AND CONDITIONS APPLICABLE TO Life's Great with \$500 Cash Promotion

#### **Promotion Entry Entitlements**

- 5. Rights of entry into the Promotion can only be acquired and exercised during the promotion period as stated and are only available to new members of Mingara Recreation Club.

# Second Chance Draw

#### Proof of qualification and payment of prizes

21. A person claiming a prize must identify themselves and prove their identity and eligibility to the reasonable satisfaction of the Club, in order to participate or for a prize to be awarded to them.

## GENERAL TERMS AND CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

- 22. The following persons are not eligible to participate in the promotion or win:
