## **TERMS AND CONDITIONS**

- 1. Total prize pool will not exceed \$100,000
- 2. No individual prize will exceed \$1,000
- 3. No prohibited prizes will be awarded
- 4. Only persons aged 18 and over will be eligible to participate in the promotion
- 5. Permit number will be displayed as required
- 6. In accordance with section 45 of the Gaming Machines Act 2001, prizes paid as part of a player reward scheme or other gaming promotion will not:
  - a. be cash
  - b. exceed \$1,000
  - c. be exchangeable or redeemable for cash.

## GENERAL TERMS AND CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

- 1. The following persons are not eligible to participate in the promotion or win:
  - (a) [*Club officers; executives and families; other employees*] Club directors or auditors; Club executives (and the immediate family of any executive); other Club employees;
  - (b) [Contractors directly involved in the promotion, and families] Officers and employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion (and the immediate family of any of them);
  - (c) [People who work on the Club's premises including the Club's onsite Business Partners] Persons whose usual place of work is within premises owned or leased by the Club, who are employed by any of the licensees or lessees of the Club;
  - (d) [People working at the Club at the time]
    Persons employed by any other supplier or contractor of the Club who at or about the time of a particular draw, are on the Club's premises in that capacity as such an employee.
- 2. Information on how to enter forms part of the promotion conditions.
- 3. The Club's licensed premises are as determined by the Club in its discretion and comprise the licensed Club building and designated outdoor areas (namely the northern outdoor area, gaming terrace and Legends outdoor areas). The Club's car park, Club's covered entry, general foyer, Mingara One Fitness, Mingara Aquatics, Bowling Greens and Athletics Track are not considered to form part of the Club's licensed premises for the purposes of Club promotions.
- 4. The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions and in a form reasonably required by the Club, in order to be paid a prize.
- 5. The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.
- 6. The Club's decisions in relation to the promotion may be made by the Club's CEO or his delegate/s from time to time (who may but need not be a Club executive), including decisions in

relation to the appointment of a judge or judges in relation to the promotion or a particular draw or draws. The Club's CEO may also (but is not obliged to) appoint one or more scrutineers for a particular draw or draws or all draws or a prize process or all prize processes. Decisions by the Club's CEO, and subject to any countermanding decision by the Club's CEO also decisions by any such delegate or judge, are final. No such decision requires any consultation. No correspondence will be entered into in relation to any such decision.

The Club is not responsible for, and is not obliged to delay a draw or a process of selecting a winner because of any delay or impediment in connection with the admission of members or where permitted non-members or in the completion of entries to the promotion or in seeking to attend any draw or to attend the process of selecting a winner.
- 8. Further, the Club is not responsible for persons being located in areas within the Club's premises in which PA announcements are not able to be heard, nor for the audible integrity of those announcements anywhere on the Club's premises.
- 9. A prize will not be awarded or paid where in the Club's reasonable opinion it arises as a result of a machine or other technical malfunction.
- 10. The Club has no liability for acting on or promulgating any incorrect or inaccurate information, due to any error to any equipment or programming associated with or utilised in the promotion or any technical error or error by any third party.
- 11. Promotional entry includes SMS, website and in house entry barrel (virtual). All entries will be collated into a form (excel spreadsheet) and drawn from a computer generated device. These entries will be each coded with an individual number and the generator will determine the winner.
- Website entries will be through <u>www.mingara.com.au</u> Entries will be made by a form on the website. These entries will be collated into an excel spreadsheet. Data will not be passed to third parties.
  By filling out the form, entrants will automatically allow Mingara Recreation Club Ltd to obtain these details for future communication.
- 13. Prizes are strictly not transferable or negotiable and are provided to the winner as stated within the promotion conditions prizes cannot be exchanged or altered.
- 14. The collection, use and disclosure of personal information provided to the Club in the course of the promotion is subject to these conditions and is otherwise governed by the Club's Privacy Policy. Please ask for a copy of that Policy if you are not aware of its contents. Members not wishing to participate in automatic draws should notify the Club's CEO's office in writing as soon as possible.

All advertising material will contain the approved Permit Number.
