Terms & Conditions Effective 2026

TERMS AND CONDITIONS APPLICABLE TO MINGARA RECREATION CLUB LTD'S Car Win & Drive PROMOTION:

1. The promotion is authorised under NSW Authority: TP/05413
2. The Promoter is Mingara Recreation Club Ltd ABN 81 001 662 648.
3. The Car & Cash Party promotion is only open to financial current Ordinary, Special, Life and Provisional members of Mingara Recreation Club Ltd (the Club). However, the promotion is not open to any member whilst their membership is suspended.
4. Members who are un-financial are not eligible to participate or claim a prize in this promotion.
5. Members of other registered clubs that encompasses the Mingara Leisure Group are not eligible to participate or claim a prize in this promotion.

Promotional Period

6. The promotional period commences on and from Sunday 27 September 2026 at 19:00 and concludes Friday 4 December 2026.

Promotion Entry Entitlements

7. A member is entitled to one (1) ticket in the Promotion for each one hundred (100) Reward Points which the member spends with the Club or with any participating outlet on the Club's licensed premises.
8. A member is also entitled to one (1) ticket in the promotion by swiping their membership card at any of the Membership Kiosks located throughout the Club's premises. A member is only entitled to one (1) such ticket each day (00:00 hours to 23:59 hours) from 19:00 Sunday 27 September through 19:00 Sunday 29 November
9. A member may also be allocated bonus tickets, up to one hundred (100) tickets per occurrence, throughout the promotional period by participating in digital and Club promotions. These include but are not limited to attendance at shows and events, the completion of online competitions and surveys and random swipe bonuses issued through Mingara Recreation Club Ltd Membership Kiosks.
10. Multiple tickets are permissible.
11. For a member to be entitled to a ticket (s) into the Promotion in the circumstances outlined, they must initiate the redemption of tickets into entries to be eligible into the Promotion's weekly draws. A member can only initiate the printing of tickets at one of the Membership Kiosks within the Club's premises. On each occasion, the tickets issued will reflect entry/entries to which the member has become entitled since last initiating redemption into the draw. The tickets will show the member's number of entries that have been recorded and acknowledged. However, the binding evidence of an entry is the database record in the Club's relevant computer system, and not any printed tickets.
12. Rights of entry into the Promotion can only be acquired and exercised during the Promotion Period as stated under the Promotion Period.

Weekly Draw Details and Procedures

13. For any Wednesday weekly Draw, rights of entry cease to accrue at 19:00 hours on the day of the Draw. Members must initiate tickets for any right of entry no later than 19:00 on the day of the Draw.
14. For any Sunday weekly Draw, rights of entry cease to accrue from 19:00 hours on the day of the Draw. Members must initiate tickets for any right of entry no later than 19:00 on the day of the Draw.
15. For each Wednesday Weekly Draw, on the day of the Draw commencing at approximately 19:30 hours, (three) 3 ticket numbers and corresponding member names will be drawn one by one and from the Club's eBet system. As each member's name is drawn it will be announced via the Club's PA system. For each Sunday Weekly Draw, on the day of the Draw commencing at approximately 19:30 hours, (three) 3 ticket numbers and corresponding member names will be drawn one by one from the Club's eBet system. As each

member's name is drawn it will be announced via the Club's PA system.

16. The member must be on the Club's licensed premises at the time of the first announcement of the member name and membership number to be eligible to claim the prize.

17. The announced member must present themselves at the designated promotional stand within the Club's premises within 4 minutes of their name being called to claim a key and \$100 in the weekly Draw, otherwise, the announced member is not entitled to a prize. In that case a redraw will take place. This process will be repeated until the announced holder of the three (3) drawn tickets have duly presented themselves and been acknowledged. The Club in its discretion may adjourn the process to continue at the next weekly Draw date, if all prizes are not duly claimed by 22:30 for a Wednesday weekly Draw or by 22:30 for a Sunday weekly Draw. In the event prizes are not claimed at the final Major Draw under this permit (04 December 2026) then the draw will continue until all prizes are claimed.

18. Although three (3) numbers will be drawn, a single member may be the holder of multiple drawn entries. For each weekly draw there will be three (3) weekly draw winning tickets they will be awarded \$100 and a unique entry number key (1-60). The keys will be drawn from a bowl by the member to determine their position for the car give away on Friday 04 December 2026 at 20:00. Keys are non-transferable.

Second Chance Final Keys

19. The Second Chance final key(s) will be drawn Friday 4 December 2026 at 19:45. The final chance key(s) will be one final key, plus any additional unclaimed keys. The pool for this drawing will consist of all entries entered in from 19:00 Sunday 27 September through 19:00 Sunday 29 November. In addition to these Keys 5 additional keys will be pulled with any members that have swiped and redeemed points until 19:00 on Friday the 4th of December.

20. On the day of the Second Chance draw commencing at approximately 19:45, entry numbers and corresponding member names will be drawn from the Club's eBet computer systems. As each member's name is drawn it will be announced via the Club's PA system.

21. The announced member must present themselves at the designated promotions stand within the Club's premises within four (4) minutes of their name being called to claim a key, otherwise the announced member is not entitled to a prize. In that case a redraw will take place. This process will be repeated until all second chance winners have duly presented themselves and been acknowledged. A single member may be the holder of multiple drawn entries.

Major Draw

22. The Major Car Draw will take place on Friday the 4th of December 20:00 and be followed by a \$10,000 give away at 20:30; a scrutineer will be present for both of the draws.

23. The entrants for the Major \$10,000 draw are the cumulative pool of individuals that have entered in tickets for Car & Cash Party from 19:00 Sunday 27 September through 19:00 Sunday 29 November along with any members that have swiped and redeemed reward points until 19:00 on Friday the 4th of December.

24. The Car give away will be determined by a member selecting a key from a bowl of 60 Keys. A single member may be the holder of multiple key entries.

25. All weekly draw finalists must register at the designated promotions stand between 19:00 and 19:45 on the day of the draw in order to confirm their attendance for the Car Give away.

26. Eligible key finalists who fail to register between 19:00 and 19:45 will be disqualified. In this case a redraw from the total pool of tickets entered from 19:00 Sunday 27 September through 19:00 Sunday 29 November and will be repeated for each unclaimed key finalist.

27. At approximately 20:30 on Friday 4th of December, the Major \$10,000 Draw will occur

28. The name of winner for the \$10,000 Draw will be announced via the Club's PA system. The winner must then present themselves at the designated promotions stand within the Club's premises within 4 minutes of their name being called, in order to claim the \$10,000. If a member does not make themselves known within the allotted 4 minutes another name is drawn. The announced Winner must be within the Club's licensed premises.

29. The Club's licensed premises are as determined by the Club in its discretion and comprise the licensed club building and designated outdoor areas (namely the northern outdoor area, gaming terrace and Legends outdoor areas). The Club's car park, Club covered entry, Mingara One Fitness, Mingara Aquatics, Business Partner Precinct (The Creche, Mingara TAB Retail outlet, Black Belt Martial Arts, Sapphire Hair Design and 6S Health) Bowling Greens and Athletics Track are not considered to form part of the Club's licensed premises for the purposes of Club promotions.

30.From the key finalists who are then present, the ultimate winner of the Car will be determined by the individual that is able to unlock the lock box. The particular way in which the game of chance is to be conducted will be explained to the finalists collectively and over the Club's PA system to the audience. The game of chance will then proceed, and the keys are drawn in the order the members have previously drawn. The single key that opens the lock box will win the car.

31.The Major Prizes in this promotion is the Car key drawn at 20:00 and the \$10,000 cash drawn at 20:30 .

Clearing of tickets from member accounts

32.All accrued Car & Cash Party tickets on member accounts will be cleared at 19:00 on the night of the Major Draw.

33.Prior to 19:00 on the night of the Sunday 29 November, members must redeem these tickets or they will be ineligible for use as they will be cleared.

Proof of qualification and payment of prizes

34.A member claiming a prize must identify themselves and prove their identity and eligibility to the reasonable satisfaction of the Club, in order to participate or for a prize to be awarded to them. There will be no cash prize issued after 22:30 hours.

GENERAL TERMS AND CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

35.The following are not eligible to enter the promotion: The Mingara Leisure Group Executive Team (and their spouses and immediate family), The Club General Manager (and their spouses and immediate family), club Team Members, Mingara Leisure Group Directors or auditors, contractors directly involved in the promotion (and their spouses and immediate family), employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion (and their spouses and immediate family), other people who work on the Club's premises including the Club's onsite Business Partners, persons whose usual place of work is within premises owned or leased by the Club, who are employed by any of the licensees or lessees of the Club, persons employed by any other supplier or contractor of the Club who at or about the time of a particular draw, are on the Club's premises in that capacity as such an employee. Information on how to enter forms part of the promotion conditions.

36.The Club's licensed premises are as determined by the Club in its discretion and comprise the licensed club building and designated outdoor areas (namely outdoor gaming areas, the terrace and smoking areas). The Club's front door entry airlock, car parks, bowling greens and outer building detached from the main club building are not considered to form part of the Club's licensed premises for the purposes of Club promotions.

37.The Club's promotional areas (for announcements of all draws) are as determined by the Club in its discretion. Certain areas within the main club building are excluded including function rooms if in use for a private event at the time of the draws. The Club's car parks, bowling greens and outer building detached from the main club building do not form part of the Club's premises for the purposes of Club promotions.

38.The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions, in order to be paid a prize.

39.The Club in its reasonable discretion may cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, technology outages (including computer viruses), tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.

40.The Club's General Manager and/or the Promotion Team member running this promotion will appoint at least one scrutineer for any draw with a prize value greater than \$10,000.

41.Members wishing to be sure of entry should seek to complete transactions and to initiate ticket redemption as early as possible to reduce the risk of being excluded because of any shortage of service points or because of delay or crowding.

42.The Club is not obliged to delay any draw or selecting a winner because of any delay or obstruction with members seeking to redeem tickets.

43.The Club is not responsible for members located in areas of the Club in which PA announcements are not able to be heard, or for the audible integrity of any announcements.

44.A prize will not be awarded or paid where it arises as a result of a machine or other technical fault.

45.Prizes are strictly not transferable or negotiable.

46.The collection and use of personal data or information provided to the Club in the course of the promotion is subject to these conditions and governed by the Club's Privacy Policy. The Club's Privacy Policy is available at Reception or on the Club's website.

47.Members not wishing to participate in any automatic draws should notify the Club's General Manager in writing.

48.Tax and financial implications may arise from winning a prize and winners should seek independent tax and financial advice before accepting.

49.No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand the way in which the promotion operates and these conditions.

50.These conditions cannot be varied for an individual member.

51.The Club determines the designated clock from which draws are timed.

52.By claiming or accepting a prize, a person agrees that the Club may use their name, suburb, photograph, image and likeness for any marketing purposes including online/social media.

53.The Club, including its General Manager or team members, contractors or agents, have no liability for any loss or damage of any nature, or for injury or death, sustained in connection with the promotion, except any minimum liability which cannot be excluded by law (if any).

54.Members will be notified of this promotion through advertising within the Clubs Premises including a promotional display, website, social media and other digital mediums, PA announcements, or by other means at the Club's discretion. All marketing material will contain the approved Permit Number.

55.In the event that any prize is unavailable, the Club reserves the right to substitute a similar but not necessarily an identical prize, of equal or greater value.

56.The value of any prize (if stated) is only an approximate retail value in Australian dollars at the date the promotion is first launched.
